



**Annual Town Meeting
DeKalb, Illinois
April 13, 2021**

Due to the Governor's order restricting gatherings of people, and in an effort to minimize the potential spread of COVID-19, the Township held the Town Hall meeting at DeKalb Township building with the option to move to the Township garage if needed because of attendance. Everyone in attendance wore masks and practiced social distancing.

The meeting was called to order at 7:01 pm by Township Clerk Kevin Flavin at the Township offices located at 2323 South Fourth Street in DeKalb, Illinois.

Clerk Flavin lead the electorate in the Pledge of Allegiance.

Township Clerk Flavin welcomed everyone and introduced the members of the Township Board as follows: Supervisor Nancy Teboda, Highway Commissioner Craig Smith, Assessor Rich Dyer, Township Trustees Chad McNett, Mary Hess, and Lisa King (remotely).

Clerk Flavin then asked for a motion to set the moderator's pay. A motion to set the fee for the moderator at \$100 for the evening was made by Elector Craig Smith and seconded by Elector Mary Hess. A vote was taken by Clerk Flavin. No discussion. Clerk Flavin called for a vote and motion carried.

Clerk Flavin asked for nominations from the floor to appoint a Moderator for the evening. A motion to nominate Lesa Eames as the Moderator for the evening was made by Elector Chad McNett and seconded by Elector Rich Dyer.

Clerk Flavin asked if there were any other nominations and being none, the nominations were closed.

Clerk Flavin asked for a vote by raised hand to appoint Elector Lesa Eames as the Moderator for the annual meeting. Motion carried.

Clerk Flavin administered the oath to Lesa Eames as Moderator.

Moderator Lesa Eames thanked the electorate for appointing her as Moderator, and she announced she would waive the \$100 Moderator fee and would like it donated to Basics DeKalb County Mobile Diaper Pantry through the Regional Office of Education.

A motion was made by Elector Rich Dyer to accept the Minutes but then he withdrew his motion.
