

MINUTES TOWNSHIP BOARD DEKALB, ILLINOIS September 14, 2022

Call To Order, Pledge of Allegiance, and Approval of Agenda:

The meeting was called to order by Supervisor Hess at 6:00pm in the DeKalb Township Board Room. Roll call was taken by Clerk Tillotson: Supervisor Hess: Present; Trustee King: Present; Trustee Bradlo: Present; Trustee McNett: Present; and Trustee Thurman arrived at 6:01.

Also present was Highway Commissioner Smith and Assessor Dyer.

Trustee Bradlo led everyone in the Pledge of Allegiance.

The agenda was confirmed by unanimous consent.

Reports:

Supervisor Hess: Supervisor Hess mentioned that she attended a back-to-school bash and a de-escalation training for those that work with the public.



She gave updates on the Low Income Home Energy Assistance Program and mentioned that people can apply again beginning September 1st.

Supervisor Hess attended a meeting with the DeKalb County Community Foundation about a donor that left their estate to improve housing and healthcare.

She discussed the Township putting up a job posting for a general and emergency assistance caseworker.

She stated that the Township Officials of Illinois will be having their conference in person in Springfield this year.

She discussed several events that month, including electronics recycling at the Elder Care Services building on September 17th.

The Supervisor brought up a paper shredding event at the Kishwaukee Community YMCA and Oakwood Cemetery walking tour to happen on October 1st.

She mentioned the nonprofit Citizens Utility Board will give an energy saving presentation on October 18th.

A motion to receive, file, and approve the Treasurer's August budget report was made by Trustee Thurman and seconded by Supervisor Hess. Clerk Tillotson took a roll call vote: Supervisor Hess: aye; Trustee McNett: aye; Trustee Thurman: aye; Trustee King: aye; Trustee Bradlo: aye. Ayes: 5; Nays: 0. The motion passed.

New Business:

- A. A motion for the Discussion and Approval of Resolution 2022-008(T) Approving License Agreement with DeKalb Park District for light pole in Oakwood Cemetery was made by Trustee McNett and seconded by Supervisor Hess. Clerk Tillotson took a roll call vote: Supervisor Hess: aye; Trustee McNett: aye; Trustee Thurman: aye; Trustee King: aye; Trustee Bradlo: aye. Ayes: 5; Nays: 0. The motion passed.
- B. A motion for the Approval of Minutes of the Regular Board of Trustees Meeting of August 10, 2022 was made by Trustee Thurman and seconded by Trustee King. Supervisor Hess requested that the date at the top of the minutes be amended. Clerk Tillotson took a roll call vote: Supervisor Hess: aye; Trustee McNett: aye; Trustee Thurman: aye; Trustee King: aye; Trustee Bradlo: aye. Ayes: 5; Nays: 0. The notes, with the change Supervisor Hess requested, passed with unanimous consent.

Executive Session: A motion to discuss the purchase or lease of real property for the use of the public body as provided for in 5ILCS 120/2(c)(5) was made by Trustee Thurman and seconded by Trustee Bradlo. Clerk Tillotson took a roll call vote: Supervisor Hess: aye; Trustee McNett: aye; Trustee Thurman: aye; Trustee King: aye; Trustee Bradlo: aye. Ayes: 5; Nays: 0. The motion passed and executive session began at 6:35pm.

The executive session ended and the public portion of the meeting resumed at 7:18pm.
