



**MINUTES TOWNSHIP BOARD
DEKALB, ILLINOIS
July 12, 2023**

Call To Order, Pledge of Allegiance, and Approval of Agenda:

The meeting was called to order by Supervisor Hess at 6:02pm in the DeKalb Township Board Room. Roll call was taken by Clerk Tillotson: Supervisor Hess: Present; Trustee King: Present; Trustee Bradlo: Present; Trustee McNett: Absent; and Trustee Thurman: Present.

Also present was Assessor Dyer.

Supervisor Hess led everyone in the Pledge of Allegiance.

The agenda was confirmed by unanimous consent.

Reports:

Supervisor Hess: Supervisor Hess discussed updates on the Township's audit.

On July 3rd, the Human Service funding application became available. Submissions are due by July 31st.

Kim Barrios and Supervisor Hess attended the senior health fair at DeKalb High School to represent the Township.

On July 14th, Supervisor Hess will be attending a TOI Supervisor's meeting in Rockford.

On July 13th, the Township will have a booth at the DeKalb Farmer's market.

On Thursday, July 20th, The Chamber of Commerce will host its family fun fest at Hopkins Park from 5-7pm. The Township will again have a booth

On Friday, July 21st, the Township office will be closed for carpet cleaning. On that day, the Township employees will be working on the community mural and holding a staff meeting about general and emergency assistance.

Danita will be offering an employment workshop at University Village on July 31st.

She mentioned that the Secretary of State Mobile event will be held at the DeKalb Township building on August 2nd.

She discussed that PCs for People is selling desktop computers for \$80 for those who qualify.

She discussed the previous electronics recycling event, where 110 cars drove through and gave 45 TVs and 5065 pounds of miscellaneous electronics.

Clerk Tillotson: Clerk Tillotson thanked Kim Barrios for filling in for him at last month's Township meeting.

Highway Commissioner Smith: Assessor Dyer mentioned that Commissioner Smith is dealing with a family emergency and apologizes for not being able to attend.

A motion to receive, file, and approve the Treasurer's May budget report was made by Trustee Bradlo and seconded by Trustee Thurman. Clerk Tillotson took a roll call vote: Supervisor Hess: aye; Trustee McNett: absent; Trustee Thurman: aye; Trustee King: aye; Trustee Bradlo: aye. Ayes: 4; Nays: 0. The motion passed.

Unfinished Business:

- A. Supervisor Hess discussed updates on the Intergovernmental Agreement Between DeKalb Township and DeKalb Township Road District for Use of Property. The item was then postponed to next month.

New Business:

- A. Supervisor Hess discussed the COY Grant from ~~DeKalb Public Library~~ ^{Adventure Works as}. She stated that it will be postponed to next month so it can undergo further review.

B. A motion for the Approval of Minutes of the Regular Board of Trustees Meeting of June 14, 2023 was made by Trustee Thurman and seconded by Supervisor Hess. Executive Session: None.


Other Business: The next Township Meeting will be Tuesday, August 9, 2023 at 6:00pm at the DeKalb Township Board Room.
