The DeKalb Township Board of Trustees recently awarded more than \$187,000 to community-based human service agencies. The Township provides funding on an annual basis to eligible non-profit agencies who provide programs or services for the benefit of people residing in DeKalb Township. Priority is given to organizations addressing the needs of seniors, youth, individuals with disabilities, and/or the economically disadvantaged population. 

In September, The DeKalb Township arranged for FLAP (Farmworker's & Landscapers Advocacy Project) to educate participants of La Universidad para Padres with regard to workers' rights.
