DeKalb Area Alano Club - Jim Doherty

The Alano Club provides meeting space for AA, Alanon, and Sex Addiction groups. Historically they have not done outside fundraising, instead relying on donations and fundraising among group members. When they realized they would need a new roof, they applied for a grant through the Community Foundation and received funds. They also applied for a one-time grant of \$20,000 through the DeKalb County Mental Health Board to pay for updates to their current space. As they realized they would run out of funds before finishing all of the projects they needed to complete, they applied for the DeKalb Township Social Service Grant and received assistance two years in a row which allowed for the completion of the updates necessary to continue operations, while also working towards being ADA compliant.



The Alano Club has joined area Chambers of Commerce and also created a website so that their services are promoted within the community. They have also reached out to Sycamore Township and received \$1,000 as they have realized that area Townships community members attend their groups and utilize their services.

Supervisor Hess reported that the recent Shred Event was successful and was the most attended to date. Supervisor Hess and Kim Barrios will be at the Farmer's Market this Thursday (6/13). The Electronics Event is coming up this weekend (6/15). A new brochure has been created for the Supervisor's Office and will be distributed at area outreach events. The auditors have finished their review of the financials last week. The report should be available in the fall. The auditors also notified Township that this is the last year of their contract and rates will be increasing under a new contract due to the demand of services. The auditors also sent emails and letters to all board members to be filled out and returned. The letters were to address questions related to fraud compliance. Casey Bachochin, Director of General Assistance, reported on the Township's response to the Huskie Ridge fire. DeKalb Township provided \$300 in gift cards to each household affected by the fire. We are also providing up to \$1000 in security deposit funds to fire victims when they sign new leases for housing.
