



### **Dynegy Communiti Electric Aggregation Program Explanation**

On May 20, 2025 DeKalb Township Trustees approved a resolution to work with Dynegy Energy to provide electricity to Township residents located outside City limits at one of two agreed upon rates. Residents will be able to select between the traditional production method at a rate of \$.09320/kWh or the green production method at a rate of \$.0958/kWh.

The Traditional Program uses sources such as nuclear power while the 100% Green Energy option uses renewable energy. Residents will automatically be enrolled into the traditional program unless they request the renewable option.

Rates for the program will go into effect in August of 2025 and will run through August of 2028. As a comparison, the new ComEd rate beginning in September will be \$0.10151.

During the week of June 16th, DeKalb Township residents and small businesses situated outside city limits will begin to receive OPT-OUT letters. Residents and businesses located outside City limits not wanting to participate in this program will need to complete and return the opt-out card by no later than July 8, 2025. All parties with a ComEd account who do not submit the opt-out card by July 8th will be placed into the Dynegy program. There is no enrollment or switching fee, and parties may opt-out of the program at anytime.

## DeKalb Township Community Electric Aggregation Notification

Dear Resident or Small Business,

Welcome to your community electric aggregation program. Members of our community voted in favor of municipal aggregation, a program authorizing local officials to purchase electricity from a retail electric generation supplier certified by the Illinois Commerce Commission (ICC). Dynegy Energy Services, LLC (“Dynegy”) has been selected as our certified electric generation supplier.

### How You Benefit

By participating, you’ll receive the following exclusive pricing on the electric generation portion of your electric utility bill:

### Enrollment Information

Unless you choose to opt out, you have authorized and agreed to be automatically included in the program pending acceptance of the enrollment request by your electric utility. Participation will commence on your next available meter-read date thereafter. It may take up to 45-60 days for Dynegy and the community electric aggregation price to be reflected on your future electric utility bills.

If you are not currently receiving electric generation from Dynegy, your electric utility will send you a letter confirming your enrollment. To join the aggregation and receive its exclusive pricing, **no action is necessary when this letter arrives.**

Following the opt out deadline, **you may leave the program at any time and will NOT be charged an early termination fee.**

### 100% Green <sup>1</sup> Energy Option

You can also select electric generation service that is backed by **100% Renewable Energy Certificates (RECs)** at a price of **9.58 cents per kWh**. You may choose this offer at any time during the term of the program. Call 1-844-351-7691 to enroll.

## Community Electric Aggregation - Frequently Asked Questions v.5.25

### Who is Dynegy?

Dynegy is an independent seller of power and energy service and is certified as an Alternative Retail Electricity Supplier by the Illinois Commerce Commission (ICC) Docket No. 14-0455. For over 30 years, Dynegy has helped millions of Americans throughout the Northeast, Mid-Atlantic and Midwest power their homes and businesses. Dynegy delivers simple, price-protected electricity plans for residential, government aggregation, commercial and industrial customers alike. Dynegy is committed to the communities it serves and gives back through local partnerships. Our community is one of hundreds who have chosen Dynegy to provide aggregation programs.

### How was an electric generation supplier chosen on my behalf?

Community electric aggregation, referred to as municipal aggregation in Illinois, allows cities, townships, and counties to bring citizens together to gain group buying power for the purchase of competitively priced electricity from a retail electric generation supplier certified by the ICC. Residents voted to allow the community officials to contract with an electric generation supplier on their behalf. Dynegy has been selected to supply you with exclusive pricing on the generation portion of your electric bill.

#### <sup>1</sup> What is a fixed price, green, or carbon free product?

Fixed means the price you will receive each month does not change, subject to the Terms and Conditions. If this notification or the associated Terms and Conditions indicate a price for the community is a Green or Carbon Free Fixed Price product:

Green means your electricity is paired with a Renewable Energy Certificate (REC). A REC represents the environmental benefit of electricity generated by a renewable energy resource like wind or solar. For every unit of renewable energy generated, a REC is created. For every kWh you use, Dynegy purchases the percentage (%) of RECs associated with this offer from a renewable energy source, supporting renewable electricity production. The % of RECs paired with your electricity is in addition to the state-minimum requirement for Illinois. Carbon Free means the energy you use is backed by Emission Free Energy Certificates (EFECs).

#### How will I benefit by participating in the program?

Aggregation programs are intended to provide price stability. Savings are not guaranteed but may occur in months when the community aggregation price is less than your electric utility's Price to Compare (PTC).

#### What is my current utility Price to Compare (PTC)?

To learn more, visit the ICC's website at: [www.pluginillinois.org](http://www.pluginillinois.org). If you are currently receiving utility service, you can choose to continue to receive utility service without penalty.

#### What does it mean to opt out?

Opt out means that you can decide to not participate. If your opt out is received by the deadline, your pending enrollment will be canceled, you'll remain on your electric utility's standard service offer for the generation charges of your bill, and you will not receive further aggregation notifications from Dynegy until the end of the current term, or other period required by the ICC.

#### What happens if I do not opt out?

If your opt out is not received by the opt out deadline you will be automatically included in the community aggregation program.

#### Can I opt out of the program after the opt out deadline?

Yes. You may leave the aggregation program at any time. You will not be charged an early termination or cancellation fee if you choose to leave the program at later date for any reason.

#### What are my energy supply choices if I opt out?

If you opt out or leave the program prior to the current term end you will be returned to your electric utility for tariffed service and might not be served under the same rates, terms, and conditions that apply to other customers served by the utility. This may take 1-2 billing cycles depending on your meter-read dates. Dynegy may offer non-aggregation offers in your electric utility service territory

or you may shop for an alternative retail electric generation supplier. A list of electric suppliers certified by the ICC are available free of charge upon request from the Illinois Power Agency or [www.pluginillinois.org](http://www.pluginillinois.org).

#### Can I rejoin the program at a later date?

Yes. If you opt out or otherwise leave the program and meet the eligibility requirements outlined in the Terms and Conditions, you may call Dynegy to return to the program at any time.

#### <sup>2</sup> What happens at the end of the current term?

Per Illinois regulations, aggregation participants must be presented with the opportunity to opt out of the program every time there is a material change in the aggregation program. This program does not automatically renew and prior participation does not constitute eligibility for subsequent terms. If still eligible prior to the end of the current term and the aggregation is renewed for a subsequent term whether with Dynegy or another supplier, you will receive a new opt-out notification communicating the terms and conditions of service and the new exclusive price. You can choose to opt out, rejoin, or remain in the program.

#### Why am I receiving this notification if I previously opted out?

Opt out notifications are sent to all eligible accounts listed on the utility's aggregation list at the start of a new term regardless of any opt out from a prior term or program. If you receive a new opt out notice, you must take affirmative action to opt out once again.

#### Can I still have my bill payments automatically deducted?

Yes. How you pay your electric utility bill will not change.

#### Will Dynegy continue budget billing my supplier charges?

Dynegy does not provide budget billing on the supply portion of your bill. Contact your electric utility regarding their budget billing program.

#### Who is NOT eligible for an electric aggregation program?

The following customer accounts are not eligible for this program: 1) accounts with service addresses outside the geographic boundaries of the contracted community or participating communities 2) small commercial accounts with usage greater than 15,000 kWh per year or 3) accounts enrolled with your electric utility's free service tariff or 4) accounts participating in a utility community solar program. Customers receiving service from another competitive supplier, accounts on a special arrangement with the utility such hourly service customers, those with overdue payments, and eligible residents who were not sent this notification will NOT be automatically included in the program but may call Dynegy to opt in at any time. If your account subsequently becomes ineligible after enrollment or has an outstanding balance, Dynegy reserves the right to return the account to the electric utility's standard service offer. To the extent possible, Dynegy may attempt to identify if it serves another program for which you are eligible.

#### Can I participate if my account is net-metered?

Yes. If your account is taking service under a net-metering tariff you are eligible to participate and will continue to receive the benefits and any compensation owed through your electric utility per the utility tariff and state rules. However, 83 Ill. Adm. Code 470.210(b) requires us to advise net-metering customers, pursuant to Section 16-107.5(d)(3) and (e)(3) of the PUA, that they may forfeit credits for electric supply service and delivery service, or both, if they participate in a municipal aggregation. Dynegy does not provide credit or any compensation for excess generation.

#### How can I report a power outage or problem with my service?

You will continue to call your electric utility for power outages, problems with your service, or questions about your monthly bill.

These Terms and Conditions apply to you because you are enrolling for electric generation service with Dynergy Energy Services, LLC (“Dynergy”) through either (a) affirmative consent or (b) not opting out of your governmental aggregator’s program with Dynergy (the “Program”). If you enroll by affirmative consent, these Terms and Conditions are your Agreement (“Agreement”). If you choose to remain in the Program by not “opting-out” or exercising the right of rescission, these Terms and Conditions and your opt-out notification are your Agreement. Please keep a copy of this Agreement for your records.

Dynergy is an independent seller of electric power and energy service certified by the Illinois Commerce Commission (“ICC”). As an Alternative Retail Electric Service (“ARES”) provider, Dynergy will supply the electric generation to your Electric Utility (“EU”) based on your usage. Your EU then distributes or delivers the electricity to you. Dynergy sets the electric generation service price that the customers pay. Generation prices are the charge for the production of electricity. The Federal Energy Regulatory Commission regulates transmission prices and services which are charges for moving high voltage electricity from a generation facility to the distribution lines of the EU. The ICC regulates distribution prices and services which are the basic service for delivering electricity over a distribution system to a customer from the transmission system. As authorized by 20 ILCS3855/1-92, Dynergy sells electricity and related services and equipment to corporate authorities of municipalities or boards of county supervisors acting as governmental aggregators of residential and small commercial retail electrical loads located within the municipality or the unincorporated areas of the county.

**Eligibility:** Only residential and small commercial customer accounts with service addresses located within the geographic boundaries of the community or participating communities as defined by the Program master agreement may enroll in this offer. The following customer accounts are not eligible for this offer: (1) accounts with service addresses outside the geographic boundaries of the Program, (2) commercial accounts with usage greater than 15,000 kWh per year, (3) accounts enrolled under their EU’s free service tariff, or (4) accounts participating in an EU community solar program. Accounts under contract or shopping with another ARES provider or participating in a residential real-time pricing program with the EU are not eligible for automatic inclusion in the aggregation Program but may enroll by affirmative consent. Dynergy reserves the right to refuse Program enrollment to any account with an outstanding balance and such accounts may be excluded from automatic inclusion in the Program. If you enroll by affirmative consent, you are responsible for providing Dynergy with accurate account information and attesting to the account’s eligibility for the Program. If said information is incorrect, Dynergy reserves the right to reprice the applicable account(s) or terminate the Agreement. EU tariffs under which you are served, including your EU rate code and the EU-provided aggregation lists are subject to change over time. You understand that the EU is responsible for creating the aggregation list, which may not always be accurate. You understand it is your responsibility to ensure the EU’s records reflect your accurate service and billing addresses. If any account does not meet these eligibility requirements or is deemed ineligible after enrollment, even if previously served in the Program, Dynergy reserves the right to terminate this Agreement and take the necessary action to return you to your EU’s applicable tariffed services provided by your EU as required by 220 ILCS 5/16-103 and defined by its rates on file with the ICC pursuant to 220 ILCS 5/Art.IX (“Tariffed Service”). Prior participation in the Program does not constitute future eligibility. If you opt-out or otherwise leave the Program, you may opt back in but Dynergy reserves the right to charge a different rate.

**Price:** During the length of this Agreement, you agree to pay Dynergy the price specified in the table above for either the Default Product, or if selected, an Optional Opt-In Product for retail electric service (“Service”). Dynergy’s price does not include any applicable taxes, fees, or charges related to distribution services from the EU. Your price may include a fee assessed by an agent, broker, or consultant representing your governmental aggregator.

**Term:** As a part of this Program, your Service from Dynergy will commence with the next available meter reading after processing of the enrollment by your EU, which may take 1-2 bill cycles depending on your meter read and will continue through the term length specified in the table above (the “Term”). An explicit contract start is not defined by this Agreement. This Agreement does not automatically renew. Automatic inclusion in any subsequent renewal of the governmental aggregator’s program is not guaranteed per the eligibility requirements outlined under the Eligibility section of this Agreement. During the Term of this Agreement, Dynergy and your governmental aggregator may extend the term for additional periods of time pursuant to the terms of the master agreement between Dynergy and your governmental aggregator. If this Agreement is extended by your governmental aggregator, you may still opt out from the aggregation program at any time without incurring any cancellation or early termination fees. The program may be terminated prior to the length of the Agreement pursuant to the terms of the master agreement between Dynergy and your governmental aggregator. If you opt out from the aggregation program, the Agreement expires, or should the program be terminated, you will be returned to your EU’s Tariffed Service or its successor.

**Right of Rescission:** If you do not opt-out or you give your affirmative consent and are enrolled to receive generation service from Dynergy, your EU will send you a confirmation letter. You have the right to rescind your enrollment within ten (10) calendar days following the date of the confirmation letter by contacting Dynergy or your EU. The right of rescission only applies when a customer switches to a generation supplier and not on renewal enrollments. Your EU will not send a confirmation notice upon any renewal of this Agreement. Upon rescinding, you will be returned to Tariffed Service unless you choose an alternate supplier of electricity.

**Billing:** You will receive a monthly consolidated bill from your EU for both your Dynergy and EU charges. If you do not pay your bill by the due date, or if Dynergy is unable to properly calculate your charges for Service, Dynergy may cancel this Agreement after giving you a minimum of fourteen (14) days written notice. Upon cancellation you will be returned to your EU’s Tariffed Service. You will remain responsible to pay Dynergy for any electricity used before this Agreement ends, as well as any late payment charges, if applicable. Dynergy does not charge you switching fees. Your EU may charge you switching fees. Dynergy reserves the right to convert you from consolidated billing to dual billing if such a conversion will facilitate more timely billing, collections, and/or payment. Furthermore, your failure to pay EU charges may result in your electric service being disconnected in accordance with the EU tariff. Dynergy does not offer budget billing, but you may contact your EU to enroll in your EU’s budget billing program if applicable. If you do not pay the full amount owed Dynergy by the due date of the bill, Dynergy reserves the right to charge a 1.5% per month late payment fee.

**Customer Cancellation or Early Termination:** You may terminate this Agreement at any time, for any reason, without termination fees or penalties. In the event the Program is terminated through the Eligibility, Force Majeure or Regulatory Out provisions described herein; you will be returned to your EU’s Tariffed Service. If Dynergy terminates this Agreement under this provision, you will not be responsible for any cancellation or early termination fee. You must still pay all Dynergy charges through the date you are returned to your EU or switched to another ARES provider for service. Upon termination with Dynergy and return to Tariffed Service with your EU, you may not be served under the same rates, terms, and conditions that apply to other EU customers.

**Force Majeure:** Dynergy will make commercially reasonable efforts to provide your Service but does not guarantee a continuous supply of electricity. Certain causes and events are out of Dynergy’s reasonable control and may result in interruptions in service (a “Force Majeure Event”). Dynergy will not be liable for any such interruptions and Dynergy shall have the right to terminate or modify the Agreement without liability for interruptions caused by a Force Majeure Event, including but not limited to, acts of God, war, civil disturbance, insurrection, terrorism, fire, flood, earthquake, acts of default of common carriers, strikes, boycotts, pandemic, unforeseen maintenance, unforeseen shutdowns or deficiencies of sources of supply, inability to access the local distribution utility system, nonperformance by the EU or other similar circumstances beyond Dynergy’s reasonable control. Dynergy may decide to terminate this Agreement, and you will receive prior written notice of the termination, after which you may be returned to your EU for Tariffed Service.

**Regulatory Out:** Dynergy shall have the right to terminate or modify the Agreement without liability if there is any change in, or enactment of any statute, rule, regulation, regulatory action, policy, rider, fees, pricing structures, market structures, capacity charges, changes in load profile, ordinance, order, law, or tariff promulgated by any court, governmental authority, utility, Independent System Operator (“ISO”), Regional Transmission Organization (“RTO”) or other service provider, or any change in operating procedure, (“Change in Law”) which alters to the detriment of Dynergy its costs to perform under this Agreement or Dynergy is prevented, prohibited, or frustrated from carrying out its intent under the Agreement. If a Change in Law occurs, you may receive a notification from Dynergy providing new Terms and Conditions. This notification will include a description of one or more of the situations described above. If you do not accept the new terms, you may terminate without any further obligation by notifying Dynergy in writing within 30 days after receiving the updated Agreement. Alternatively, Dynergy may decide to terminate this Agreement, and you will receive prior written notice of the termination, after which you may be returned to your EU for Tariffed Service.

**Customer Consent and Information Release Authorization:** This Agreement shall be considered executed by Dynergy following acceptance of your enrollment request by Dynergy, the end of the ten (10) day rescission period, and subsequent acceptance of the enrollment by your EU. By choosing not to opt-out of the Program, or to affirmatively join it, you understand and agree to the terms and conditions of this Agreement with Dynergy. You authorize Dynergy to obtain information from the EU that includes, but is not limited to: billing history, payment history, historical and future electricity usage, meter readings, and characteristics of electricity service. Dynergy reserves the right to determine if your credit standing is satisfactory before accepting your enrollment request. Dynergy is prohibited from disclosing a customer’s Social Security number and/or account number(s) without the customer’s written consent except for Dynergy’s collections and reporting, or assigning a customer’s contract to another ARES provider or except as permitted or required by 83 Ill. Adm. Code 412.240, 220 ILCS 5/5-110, 815 ILC 505/2RR or other applicable law. Dynergy will not disclose a customer’s billing, usage, or load data except as permitted by 20 ILCS 3855/1-92, 220 ILCS 5/16-122 or applicable law. Customer authorizes, but does not obligate, Dynergy to exercise customer’s governmental aggregation opt-out rights.

**Assignment:** Dynergy may assign its rights under this Agreement to another, including any successor, in accordance with the rules and regulations of the ICC without prior consent. You shall not assign its rights and/or obligations under this Agreement without prior written consent of Dynergy.

**Limitation of Liability:** Dynergy assumes no responsibility or liability for the following items that are the responsibility of the EU: operation and maintenance of the EU’s electrical system, any interruption of service, termination of service, or deterioration of the EU’s service. The EU remains responsible for the delivery of electric power and energy to the customer’s premises and will continue to respond to any service calls and emergencies. In the event of a power outage, you should contact your local EU.

**Environmental Disclosure:** You agree that Dynergy will make the required periodic updates to the environmental disclosure statement electronically on our website which can be located at [www.dynergy.com/environmental-disclosures](http://www.dynergy.com/environmental-disclosures). Dynergy will also provide the information upon request.

**Net Metering:** If you are a qualified Illinois net-metering customer under 220 ILCS 5/16-107.5, you have an obligation to notify Dynergy of that status. Subject to the Eligibility requirements above, Dynergy will serve net-metering customers in accordance with the terms and conditions established by the EU, Illinois law and/or the ICC. To the extent there are changes in EU practices, Illinois laws or regulations, including any modification to the state-mandated net-metering compensation, Dynergy’s administration of this program will change accordingly. Such change may include Dynergy returning net metered accounts to the EU’s standard service offer or its successor.

**Dispute Procedure:** Contact Dynergy with any questions concerning the terms of service by phone at 1-844-351-7691 (toll-free) from 7 a.m. to 10 p.m. CST weekdays, in writing at Dynergy Energy Services, LLC Attn: Customer Care, PO Box 650764, Dallas, TX 75262-0764, or by e-mail at [DESCustCare@dynergy.com](mailto:DESCustCare@dynergy.com). If your complaint is not resolved after you have called your electric supplier and/or your electric utility, or for general utility information, residential and business customers may contact the Consumer Services Division of the ICC for assistance at 1-800-524-0795 or visiting their websites at [www.icc.illinois.gov](http://www.icc.illinois.gov) or [www.pluginillinois.org](http://www.pluginillinois.org). While a customer complaint is pending investigation by Dynergy and/or the ICC, you are not obligated to pay the disputed portion of the bill. However, you remain obligated to pay any undisputed portion of the bill. You will be notified when the investigation is completed, and, if incorrect, your bill will be adjusted accordingly. **WAIVER OF RIGHT TO JURY TRIAL OR TO CLASS ACTION OR CLASS ARBITRATION: TO THE FULLEST EXTENT THAT APPLICABLE LAW ALLOWS, YOU AND DYNERGY AGREE THAT: (I) YOU AND DYNERGY WAIVE ANY RIGHT TO TRIAL BY JURY, AND (II) NEITHER YOU NOR DYNERGY WILL SEEK OR SUPPORT ANY ORDER CERTIFYING AN ACTION OR ARBITRATION INVOLVING YOU AND DYNERGY AS A CLASS ACTION OR CLASS ARBITRATION OR JOIN OR PARTICIPATE AS A PARTY OR CLASS MEMBER IN ANY ACTION OR ARBITRATION BY ANOTHER PARTY AGAINST EITHER YOU OR DYNERGY.**

**Renewable Energy Certificate (“REC”) Disclosure:** The Green product matches the percentage (%) of your electricity usage specified in the table above with RECs. A REC represents the environmental benefits of 1 megawatt hour (MWh) of electricity generated by a renewable energy resource. Your REC purchase supports renewable electricity production in the region of generation. For every unit of renewable electricity generated, an equivalent amount of RECs is produced by purchasing and pairing RECs with your electricity service. You are using and receiving the benefits of that renewable electricity. Renewable energy certificates are not sold more than once or claimed by more than one party.
